REPRESENTATION ORDER

THIS MOTION, as made by the Plaintiff, Zongidaya Nelson, on his own behalf and on behalf of the Roseau River Anishinabe First Nation, for a Representation Order authorizing him to proceed as the representative plaintiff for a group of persons who are entitled to receive the annuity payment pursuant to Treaty 1 from the Crown, was

considered this day in writing at the Law Courts Complex, 401 York, in the City of Winnipeg, in the Province of Manitoba.

ON READING the pleadings herein, the Joint Case Management Brief of Counsel for the Parties dated June 6, 2021, the unanimously signed and executed Band Council Resolution from the Roseau River Anishinabe First Nation as submitted to this Honourable Court in support hereof, and upon noting the consents of the parties by their counsel to the granting of the Representation Order;

1. THIS COURT ORDERS that a Representation Order is granted in favour of the Plaintiff, Zongidaya Nelson, to bring the claim forward on his own behalf and on behalf of the Roseau River Anishinabe First Nation, to represent a group of persons who are entitled to receive the annuity payment pursuant to Treaty 1 from the Crown.
2. THIS COURT ORDERS that the Amended Statement of Claim as referenced herein shall be further amended to remove all references to The Class Proceedings Act and further directs that the Amended Statement of Claim and style of cause therein shall be further amended to reflect the status of the proceeding as a representative action.
3. THIS COURT ORDERS that Zongidaya Nelson shall provide notice of the claim by providing a copy of the Re-Amended Statement of Claim, and a copy of this Order, to the Chief and Council of all First Nations which are members of

Treaty 1, other than the Roseau River Anishinabe First Nation, by way of registered mail, and the Plaintiff will provide a report to the Honourable Court and to the Defendant upon such notice being effected.


