

LSO CPD Hours for 2024

We are happy to assist you in fulfilling your LSO CPD hours for 2024. Set out below are links to some Substantive and EDI recordings that qualify for CPD under the LSO mandatory CPD regime.

When selecting from the list, consider the following:

- The Law Society's CPD requirement consists of at least 12 hours of Eligible Educational Activities each calendar year. The CPD requirement includes of a minimum of 3 Professionalism Hours (which includes 1 EDI Hour) and 9 Substantive Hours.
- The LSO has removed the 6 hour maximum for viewing recordings on your own. You may watch all 12 required CPD hours on your own in 2024.
- After viewing, be sure to keep a record of your activity and then report your credits on LSO Connects. See the instructions below.

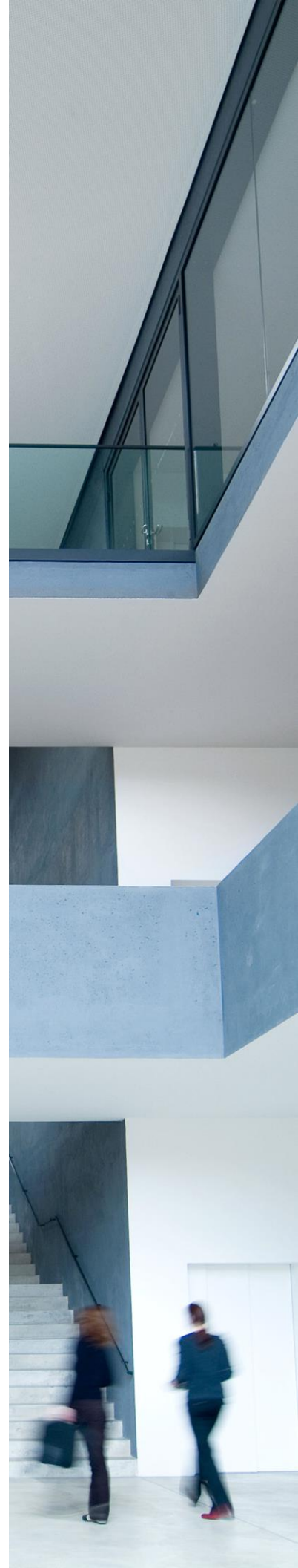
